





FUSE: Fuse	Please make sure to use quick acting fuse 2A
C1: Capacitor for input voltage smoothing	Capacitance : 22 to $47\mu$ F Rated voltage : 200V or higher Ripple current is 0.22Arms above.
C2: For noise terminal voltage reduction	Capacitance : $0.1\mu$ F to $0.22\mu$ F Rated voltage : 200V or higher Film capacitor or ceramic capacitor. Reduce the noise terminal voltage. The constant value should be evaluated in the set.
C3: Capacitor for Output voltage smoothing	Capacitance : $220\mu$ F to $820\mu$ F Rated voltage : $25V$ or higher, ESR is $0.15\Omega$ max. Ripple current is 1.0Arms above. Output noise voltage is infulenced.Please evaluate it in the actual set.
